

Horizon Federal Credit Union "Thanksgiving Dinner Giveaway" Official Rules and Regulations

NO PURCHASE NECESSARY TO ENTER OR WIN. OPENING AN ACCOUNT, TAKING A LOAN FROM HORIZON FEDERAL CREDIT UNION, OR OTHER PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. RULES ARE SUBJECT TO CHANGE AT ANY TIME AND WITHOUT NOTICE.

1. Eligibility for Promotion: Participation is limited to eligible persons who are 18 years or older and U.S. residents. By submitting any entry, you agree to be bound by these Official Rules. The Promotion period begins on October 19, 2023, ends on November 13, 2023, and applies to entries actually received by the Credit Union during this period. Employees and Board Members of the Credit Union and their immediate family members are not eligible. All winners will be notified by the Credit Union. If any prize is not claimed with fourteen days, an alternate winner will be chosen.

2. Prizes: The Credit Union will award two prizes each valued at approximately \$200.

3. Sweepstake Entries. To enter in person, individuals must complete an official entry form and place in into the drawing box located at each branch location. To enter by mail, you must print your full name, address, telephone number, email address on a postage-paid 3" by 5" green index card, along with a photocopy of a valid driver's license, and mail it to: Horizon Federal Credit Union's Thanksgiving Dinner Giveaway, 2849 Reach Road, Williamsport, PA 17701. One entry per envelope. Only mail entries received during promotional period will be accepted. Hand-delivered entries will not be accepted. Mechanically and electronically reproduced write-in entries or entries submitted via any third party not directly affiliated with Horizon Federal Credit Union will not be accepted. Entries are limited to a maximum of one per individual; multiple mail entries do not increase odds of winning. Horizon Federal Credit Union is not responsible for lost, late, illegible, misdirected, mutilated, incomplete or postage-due mail entries. Incomplete or illegible entries will be disqualified. To claim the prize, all winners must sign and return a release and an affidavit of eligibility and publicity release to Horizon Federal Credit Union at 2849 Reach Road, Williamsport, PA 17701, within 14 days of notification, or prizes will, in the Credit Union's discretion, be forfeited. Prize must be picked up in person prior to November 20, 2023 at the location of entry or prize will, in the Credit Union's discretion, be forfeited. The prize will be awarded only if entrants comply with these Official Rules. No other consideration will be paid.

4. Void where prohibited by law. All federal, state and local laws and regulations apply.

5. Tax Responsibility. Prize winners are responsible for all federal, state, local or other taxes or other assessments that may be associated with or imposed upon the winner of any prize in this promotion.

6. Release of Claims: All winners, members of any winners household, relatives and persons who use any prize awarded by the Credit Union, and such persons heirs, assigns, executors, and administrators release and exempt the Credit Union and its directors, officers, employees and agents from any and all claims, actions, demands, losses in action and damages which they have now or any time in the future arising from use of any prize, including personal injury or death.
