- This offer to purchase is *irrevocable*. If the successful bid is not honored by the bidder, he or she may not be permitted to bid on any future items made available by Horizon at future auctions.
- Should Bidder's offer be accepted by Horizon, the Credit Union will notify the Bidder of an accepted offer, and Bidder will have two days to respond and up to five days to pay the full price or arrange financing unless an extension of time has been approved by Horizon. Bidder must pay Horizon in certified funds, cash, or wire transfer.
- Should Bidder's offer be accepted, Horizon will take all necessary steps to transfer title of the vehicle to Bidder as soon as possible. Bidder will be responsible for satisfying all taxes and transfer fees pertaining to the sale of said vehicle. Upon payment, title of the vehicle will pass and at such time the successful bidder assumes full risk and responsibility for the vehicle and neither Horizon nor its agent(s) shall be responsible for any loss or damage to the vehicle from any source.
